 - 1. Exception is transportation budget/car tabs
 - a. Just passed house, headed to Senate
 - b. Neither operating budget has passed yet
 - iii. Telecomm relatively quiet this year
 - 1. HB 2629 weighs utility charges electric water gas
 - 2. 6240 concerning underground utilities (recommendations from call before you dig)
 - iv. Major bill in 2019 SB5511 expanded broadband service and resources statewide
 - 1. Establishes goals for broadband, 25/3 download upload standards
 - 2. Central broadband planning board for the state
 - 3. Public Works board has hired broadband staff
 - v. Bills that have died
 - 1. 2414 digital equity in broadband
 - 2. 2922 pole attachments for PUDs
 - vi. 5G telecomm policy
