      - 1. HB 1064 Short Description: Requiring the disclosure of high-speed internet access availability in the seller's disclosure statement.
        - a. A good idea to tell home buyers ahead of purchase what internet speed is available (or not available at all)
      - 2. SB 5110 Short Description: Promoting greater access to the internet by modifying permitting, taxation, and other standards for telecommunications companies and facilities.
        - a. Check on conflicts with small cell deployments
