 - i. New leadership at AWC started State Broadband Deployment Best Practices Taskforce (WA State Broadband Office WSBO)
 - 1. Microtrenching and permitting pilot projects
 - ii. Alice put out to listserv WSBO call for comments
 - iii. FCC opened broadband serviceable location fabric bulk challenge process poor federal maps for where broadband is or not. FCC wants better maps to determine where infrastructure money should be spent. Maps will be used for grant requests.
 - iv. Franchise fees and PEG fees for OTT state legislative effort
 - v. In Seattle watching what Wave is doing over IP on fiber network, not cable network...they have infrastructure in the right of way to make that service possible.
 - 1. Rainier Connect in Tacoma/PC is the same issue. Fiber backhaul that makes OTT possible is still located in the ROW.
